

Oregon Area Assembly Minutes

March 19, 20, 21, 2010

The Assembly was called to order by Chairperson, Rita, B, at 8:30 AM with a moment of silence followed by the Serenity Prayer. The Steps were read by Colleen and the Traditions were read by Shannon.

Roll Call - New GR Introductions and Welcome – Mary W.

- The District Representatives introduced their GRs, and welcomed visitors from their districts.

Announcements: Rita B., Chairperson
Read the 'Microphone and Voting Statement'.

Housekeeping: District 7 – Sue

Secretary's Report: Mary W

- A motion was made and seconded to approve the minutes of the November 21-22 2009 Assembly.
- Motion carried

Treasurers Report: Bunny G (see p 15 for budget)

- Checkbook balance is \$3980.25 as of 3/21/2010, and we need to request for groups to donate money to Area.
- The Treasurer has changed name of the Treasurers report from Expense & Income name to Cash Flow Statement.
- Request that GRs let Treasurers know that Bunny has replaced Glen even though address is still the same.
- Checks sent to Oregon area need to have group name, district # and WSO #.
- As of Dec 15 the Treasurer has sent out 55 letters requesting this information from groups that have sent checks without this information.
- There was a Discussion on whether we need to vote on Treasurer's report; consensus was that we don't need to so will not do in the future.

- Had Roland explain what panel is – 60 areas across the US, Canada and Bermuda- 1/3 of delegates rotates in and 1/3 rotates out each year.
- Returned from NW delegate meeting in Alaska
- Embrace the controversy it is part of your spiritual growth was one delegate's message to Bette. The job description for the Area Delegate is found on page 146 of the Service Manual. e-communities are part of members web site with information for each of the area's coordinators and delegate. e-community report:
- Cindy, Alternate Delegate has begun recertification process for Alateen, Billie is helping Cindy with this. Helen M, Group Records Coordinator – report on p 3 & 4.
- Glenn G, literature coordinator – there were to be two conferences to choose from one this Saturday, the other is Wednesday. I received a phone call saying Saturday was canceled because only three people chose it. I changed to Wednesday as 28 different areas have already signed up. In checking lit e-communities I came across a literature question and answer sheet. I sent a copy to the Chairperson and she plans to use them during breaks.
- Joanne C. and Colleen M, Public Outreach and Cooperating with Professional Community:
 - Carrying message of hope. e-community has lots of information.
 - The current focus is on the Lois W story that will be on CBS.
- Carolyn, Forum Coordinator, likes how simple e-community has made getting on to site. Has received quarterly update. The number of Forum subscriptions has dropped below 20,000 for first time. GRs are forefront for encouraging Groups to utilize the Forum. Each group is given free subscription. We need to raise awareness of the Forum.

- o Jodie, Archives Coordinator – responsible for collecting history of groups, and for storage of Oregon Area historical materials.

Highlights of WSO 2009 annual report

Gas mileage: Sue B., Audit Budget Committee

Suggested a change the last sentence in reimbursement instructions in section 4, on p 3 of the Oregon Area Handbook. The reason for the motion is that every few years we have to change mileage reimbursement because prices go up or go down significantly. If motion is passed, the reimbursement will be based on the price of gas at the time of the Assembly or AWSC.

Reported on what TEAM is, what TEAM events are happening and a potential collaboration with Washington to put on a TEAM event third weekend in June, 2011 on SeaBeck.
Taskforce appointed to look into TEAM event at SeaBeck.
Colleen, Billie, Norma, Joanne, Paula Shannon and Judy
Timeline - April 15

- Because Washington had checked with Seabeck and only 2 weekends were available in June 2011, the assembly was asked IF they wanted to proceed with a TEAM event in June 2011 with Washington, in Washington. The Consensus was yes. The task force met during the assembly, and it was brought back to the assembly that we have AWSC in June, graduations, weddings, vacations and June is a pretty full month. So the assembly was asked, "Do we want to proceed with June 17, 2011, or choose not to proceed at this time." The vote was yes for June 17th. We needed a \$5000 deposit for Seabeck one year in advance (and it was not in our budget), so the assembly was asked IF 25 Oregon members would be willing to donate ASAP \$100 towards the deposit for Seabeck. At least 30 members raised their hands. One year in advance of June 17, 2011 is before our next meeting (AWSC in June) so all AWSC will be receiving TEAM information via the internet.

Reports from Action Committees

E-Community Sharing
Group Records Coordinator Report: Helen M.

- A thought force has been established to address what are really Beginners' Meeting or whether the box on the GR-3 form was checked to encourage newcomers' attendance at a regular AI-Anon meeting.

The reason for the "thought force" is to see if the Beginner Meetings are meeting the needs of newcomers and how those meetings are supported by AI-Anon groups that meet at the same time and location.
Beginner meetings. I have a list of those meetings and there is a note the DR folders if you have Beginner meetings in your districts. A questionnaire sent to the thought force indicated there is little consistency in their Areas regarding what meetings are actually Beginners meetings.

RESOURCES ON E-COMMUNITIES

Forms, guidelines and latest version of the Service Manual are posted on the site. In my case, the latest version of our change form, GR-1, is posted there. I can download and copy these forms. The one I am and have distributed is the most up-to-date copy.

CONFERENCE CALL

- I was advised of conference call to be held Feb. 27 by E-Community website, and very shortly thereafter a summary was posted. A separate document on this summary is to be shared.

- **MULTIPLE MEETINGS** – It is better to register separately, especially if more than 3 meetings a week. Reason for this is that sometimes all groups do not get the same information and it is easier for group records to retain accuracy.
- **NAMES OF GROUPS** – This is addressed on p33 and p 78 of Service Manual. Sometimes the group and Group Records will get a marked up version of the name if it is not in keeping with Al-Anon principles as outlined on these pages in the service manual.
- **WHY DOES IT TAKE SO LONG FOR CHANGES TOTAKE PLACE AT WSO?** - When changes are sent electronically, they are put into their database, this could take several days since they now do not have the capability to input directly into the database.
- **INCOMPLETE INFORMATION** - Last names must be included on current mailing address. Address for meeting must be exact location, not post office box, and meeting zip is important because used as search criteria on the toll-free meeting line to provide meetings in surrounding areas.

OREGON AREA GROUP RECORD PROCEDURE – Helen M.

In accordance with an Oregon Area Motion passed at the Oregon Area Assembly District Representatives work with their respective Group Representatives to maintain current and accurate District Group Records. This creates more participation of the Group Representatives, therefore creating more understanding about how important it is to keep current information and to make sure it is accurate.

- **WHEN CHANGES ARE NECESSARY:**
 - District Representatives send meeting changes (updates) to the Oregon Area Group Records Coordinator, EXCEPT Alateen. Alateen changes and new Group registration are to be sent directly to Area Alateen Process Person.
 - The Oregon Area Group Records Coordinator would then verify that all information (Group ID#, District #, Area#) is accurate and the appropriate WSO form is complete. Once verified, the Oregon Area Group Records Coordinator will then electronically send updates to WSO and Web Site Coordinator, when applicable. When the current WSO change form is used, it is only necessary to fill in the Group#, District#, and the change that is to be made.
- **BI-ANNUAL PRINTOUTS**
 - The Oregon Area Group Records person receives, in Excel, a bi-annual printout from WSO. This can be filtered by District and then transported into a meeting format for distribution to the DRs. The DR compares their current meeting list to the printout supplied by the Area Group Records person and responds back if there are any differences.
 - The Area Groups Records Person in turn electronically notifies WSO and Web Site Coordinator, as the final step in this cycle of change.

ACTION COMMITTEES BREAKOUT report – Judy J

Purpose: provide time and place to work together to find ways to strengthen Al-Anon in Oregon. Ways to carry our message of hope. Meet and brainstorm ideas. Promote ideas to carry the message.

Action committees were started 9 years ago. Some areas love it and some don't. Let's give it our best and see how it goes.

- #5 – BUSINESS SERVICES.... Treasurer and audit budget members

Hope is to get at least 1 GR from every district on each committee.

DR Breakout – Facilitator: Melissa Recorder: Chris K.

Meeting opened with introductions and Melissa asked for possible topics to be discussed.

TOPICS:

1. Information on Group Records by Helen. - Helen will be giving a full report on Sunday but she wanted to go over some of the details with the DR's. All DR's received a printout. Please check and make sure they are correct. Follow the links of service to get information to WSO about the groups. GR to DR to Oregon Group Records Coordinator to WSO. When Helen receives the information she usually has a 24 hour turnaround time to WSO. Annual update from WSO comes out in July from WSO. You can send that back directly to WSO after you receive it and check it.

She also said that the information on the website is not all correct and she and the web master are working together to resolve this issue. Only Helen should give information to the web master about changes on groups. Any group information/changes can also be e-mailed to Helen. She needs three things when you put a change in for a group. 1) Group #, 2) Registered Group name; 3) District name.

2. Announcement about June AWSC – there is a group rate available at the Pioneer Villa Travel Lodge. If you make a reservation tell them you are with AI-Anon to receive the discount.
3. Questions on the process of how to get an Alateen Sponsor certified. Roland was present and assisted with this discussion. The process is:
 - a. Get fingerprints and fill out application. Finger prints go to OSP; Applications goes to DR. DR can also mail fingerprints.
 - b. DR contact references, verifies the information (DR signature is verifying info on application is true and applicant meets the minimum safety requirements. (If DR signs off on references and application then send to the AAPP - Area Alateen Process Person (Alternate Delegate – Cindy E.)
 - c. If DR can't sign off on the application because applicant does not meet the safety requirements contact the AAPP about the matter.
4. Information from the Archives Coordinator. A printout has been put in the DR's mailboxes. Please check to see what is there for your district and turn in Group History Forms for groups that are not on the list.

Melissa asked if anyone wanted to facilitate the DR breakout group in July and Trish volunteered.

Topics suggested for July DR breakout meeting: 1) Information from other districts on Local AI-Anon Information lines and answering machines –Input from all; 2) Information about Yahoo groups for communication between meeting purposes; Sue will gather information about this.

The Group Services Action Committee Report:

The Group Services Action Committee job description is as follows:

1. Strive to maintain accurate current mail addresses for each group.
2. Educate the Area membership about Alateen and continuously promote active involvement.
3. Educate and reach out to new and seasoned GRs and the Groups they represent to assist them with group issues.
4. Encourage and educate GRs to pass information through the links of service.
5. Encourage Groups to maintain an ongoing Group History, providing education as needed.

The meeting was attended by the following 11 group representatives: Billie L, Joan W., Judy J., Mandy, Dawn B., Barb K., Kerri C. Marianne M., Jim N., Norma P., and Pat T.

Also attending were our Chairperson, Rita B., Past Delegate, Judy J., Alateen Coordinator, Loretta P., Archives Coordinator, Jodie P. two DRs, Lynda S., District 17, Trish, District 11, and Area Delegate, Bette R. Also present was Guest, Alateen member.

The first item on the agenda was a discussion on Archive issues. Jodie indicated that we may want to scan documents that are not in fireproof safes. After much discussion about costs, methods, etc, it was decided we would have a Thought Force to do research including checking with WSO about possible methods. They are to report back at our next meeting.

Jodie indicated she will bring a display of Archive material to future Assemblies. A discussion was held concerning the need for that. There were opinions on how it would be presented. Jodie will take that discussion under consideration and make a decision on what to do. Jodie put a list of group history forms that have been collected by Archives to date in each District Representative's mail box. She asked that all DR's check to see which groups HAVE NOT submitted a group history form, and assist them if needed. The forms are available on Oregon Area website. Next on the agenda was an Alateen discussion led by Alateen Coordinator, Loretta P. She indicated she is available to hold workshops on Alateen, especially regarding recruitment of sponsors. She made the point that we need to acquire certified sponsors before talking about starting a meeting. A discussion was also held about how to acquire participants. Our guest Alateen member felt that schools are a good source through counselors and principals.

Group records was briefly discussed. All changes should have three items: Group #, Group Name and District #. These should be submitted following the links of service, GR to DR, DR to WSO, Webmaster and Portland AIS. Groups and Bank accounts were briefly discussed. Groups should have a bank account under the group name approved by WSO with a federal ID number. There will be more on this at next meeting.

Membership Outreach Action Committee Report

Opened meeting with the Serenity Prayer –

Did introductions and sent a Roster around so we can send it out to member so we can communicate between meetings.

Chairperson handed out Committee Purpose Statement and Read Committee Purpose Statement-

To find ways to communicate within the fellowship about Al-Anon and Alateen activities. To cooperate and share information encouraging Al-Anon and Alateen participation in service meetings, T.E.A.M., State Speakers Meetings, International Conventions. To create a meeting environment to renew the commitment to serve, strengthen unity and actively listen to the concerns of members.

Additionally to:

*Make suggestions in maintaining website – have current area, district and group events on web.

*Challenge each district to bring at least on new person to each assembly.

*Suggest ways for GR's to talk about service events with enthusiasm (maybe 5 minute reports).

We had a brief conversation about some of the past projects; Links of Service bookmarks and the flip books for the new GR's.

Chairperson also handed out a summary of 2007 Survey regarding the communicator for History purposes:

Communicator Survey Results November 2007 Assembly

Barb L read summary of survey. There was a 50-70% response.

Barb gave her feedback on the comments, especially the strong encouragement for Alateen participation in Communicator. She reminded us the Communicator is only a forum for OR Area, not designed to be a serial magazine but an educational tool. It is defined by guidelines in the Oregon Area Handbook and printed 3 times a year at specific times—BEFORE EACH ASSEMBLY. She noted the positive feedback she got for the color version online this month.

She reminded us all groups get 4 copies of the Communicator, and Bunny said that 4 copies are going to past delegates, which is not necessary.

2010 - We are now sending 1 copy per group.

Meeting was turned over to Lisa to focus on talking about the Communicator. There is a \$1500.00 budget for the Communicator and it is sent out 3 times per year.

Lisa shared that the Communicator is a newsletter to keep groups and members informed. The purpose is to: Encourage attendance at group events; communicate AIS and local Al-Anon area events; give members information about what is going on in the area; and attract Al-Anon members to service. She read excerpts of the Guideline put out by WSO on newsletters.

She then went over the costs of distributing the Communicator now: To print 300 copies of the Communicator (12 pages) and send one copy out to all the registered groups in Oregon at bulk mail rate is \$242.77. Need at least 200 pieces of mail to get bulk rate. Can only send one Communicator per address under current rules of bulk mail. Then it is also posted on the Oregon Area Website for anyone to access and print as they want.

Alternative Distribution Ideas and Costs were then discussed.

1) Printing more copies and sending 4 copies to each group in an envelope for registered group. \$1.39 for postage + .17¢ per envelope. Cost above printing newsletter would be \$ 340.98.

2) On-line Mailing Service: Up to 500 e-mail addresses \$15.00 per month; Up to 1500 e-mail \$30.00 per month; + \$ 5.00 extra per month for graphics and we could pay an additional charge for archiving. Misty mentioned that she has worked with Constant Contact e-mailing before and it is an easy program to use.

3) UPS / Fed Ex will not take the Communicator and deliver it is too small.

4) Stop the Communicator all together – No Cost

5) Only post on the Oregon Area Website – No Cost

After Lisa presented costs the floor was opened up for discussion. Topics that were brought up for discussion were:

- Electronic Mailing is Green

- Using a mailing service provides a report that will show how many e-mails have been opened..

- Oregon area has budget to print & send Communicators, groups should not have to pay to print them.

- We could use a combination of sending hard copy to groups and e-mailing.

- Should we resend the survey done in 2007? – (last time there was only a 40% response.)

- Some people don't want to read Communicator because it is only focused on service.

- Should we have more GR sharing's about what is going on in individual groups?
- Would a change in content to the Communicator attract more interest?

There was a short side line discussion about putting information about all the Round-ups, conventions and all functions and dates in the Communicator and Lisa gave information about what is necessary to get an event in the Communicator or on the website: It has to be AI-Anon Sponsored; Flyer guidelines are in the Oregon Area Handbook and the purpose is to announce AI-Anon events. Some events suggested would not fall under these guidelines.

CHALLENGE #1: Go back to groups, introduce the Communicator to them and ask for input on what they would like to see in it and how they might like to see it distributed and have information and survey questions ready to present by July Assembly.

CHALLENGE #2: Committee needs to make a commitment to get all of the groups to fill out a survey if one is presented.

District Reports

District #1 - North Oregon Coast; Clatsop and Tillamook Counties.

Greetings! As in the past several years District #1 is busy, busy, busy. Our new district officers and GR's took on their roles in January. We eased into the year with a request to think about what kinds of goals they would like to have for this year. They were asked to bring their suggestions back to the February meeting so we could set an agenda. We had four different areas to look at:

1. District Meeting Goals –
2. Public Outreach Goals –
3. Fund Raising and Convention Participation Goals-
4. District Representative Goals-

Our District Meeting Goals are as follows:

1. A Workshop on Concepts led by myself.
2. A Workshop on Service led by our LCD Coordinator Kathi R and;
3. A Workshop on Being an Alateen Sponsor and its Rewards led by Priscilla C.
4. We also agreed that we would love to have our Delegate visit us so I will be contacting Bette to set that up.

The next set of Goals we wanted all surrounded Public Outreach. We are very lucky to have Carol K. as our Outreach Coordinator and with her guidance and the districts enthusiasm we look forward to the following:

1. Send District #1 AI-anon meeting schedules to all the motels in District #1.
2. Continue with AI-anon panel one time a month at the local treatment center in Seaside to inform the friends and family members of patients about AI-anon.
3. Continue to stock an AI-Anon brochure rack at an outpatient drug and alcohol counseling center in Astoria.
4. Distribute 400 copies of AI-Anon faces Alcoholism that we have ordered this year.

 - b. Newport – Happy Hour – GR is Paul J
 - i. Ongoing Outreach – leaving Forums with meeting lists attached
 - ii. Monthly Step Study & Tradition Study
 - c. Newport – Wednesday Ones – GR is Rita A. by visiting Re connections to share information on Al-Anon to the families of those in that rehabilitation program.
 - i. Two members volunteered to do an outreach program
 - ii. This group developed a 4th Step Study group to help remove some of the fear this step causes for new members. The group is about half and half with old timers and new members. As an old timer I am learning so much more about myself with this group.
 - iii. Several members expressed how much they enjoy the Communicator and would be willing to download a copy or copies from web site and share with other members.
 - d. Toledo – Self Discovery Study Group – GR is Misty L
 - i. A member's copy of the Communicator was mailed to her PO Box number with her full name on the front and worse the back side of the mailing was covered with Al-Anon information. The anonymity for this person was exposed.

 - e. Toledo – Yaquina – No GR at this time
 - f. Waldport – TGIF – New GR is Marilou K. She was just elected to this position last Friday. Some members expressed that they did not feel the Communicator was cost effective at this time.
3. As a DR newbie I am proud to present some of the goals this district plans to promote. It doesn't mean that they will happen but at least we can give them a try. Some of the ideas are :

Q: "If I become your friend on Facebook and you are talking about Al-Anon, how do I protect my anonymity?"

A: Refer to page 18 of the Service Manual and look at Traditions 11 and 12. Facebook is a friendship site on the web, therefore Tradition 11 is not germane in this discussion as it relates to public relations policy. Tradition 12 would be important to keep in mind. Anonymity is also discussed on pages 83 and 84 of the Service Manual. As a member of Facebook, I have both friends that are in Al-Anon and friends that are not. In either case, I DO NOT post information about Al-Anon on anyone else's page. I may make a comment about Al-Anon if they have already posted something about it. If I do, then it is MY anonymity that I have broken, but that is my choice. If you want to protect your anonymity, don't mention your involvement in the program on your home page or comment on other's pages. You can delete other's comments on your page and send them a friendly reminder if they break your anonymity, just as you would in person if someone broke your anonymity. When a friend's post shows on your Facebook wall, whether it be about Al-Anon or any other topic, it just means you have a friend with that opinion, not that you share it.
